



**Assisted Decision-Making (Capacity) Act 2015**  
**Status update – Preparation for commencement**  
**ADM Implementation Steering Group**  
**April 2022**

## **Introduction**

This document is the fourth status update on the commencement of the Assisted Decision-Making (Capacity) Act 2015 and the work and actions that are being undertaken in the HSE to prepare for commencement in June 2022.

This document is issued after each monthly HSE ADM Implementation Steering Group meeting to steering group members for further dissemination to colleagues and staff.

## **Pre-legislative scrutiny**

The Oireachtas Committee for Children, Equality, Disability, Integration and Youth has completed its pre-legislative scrutiny of the general scheme of the Assisted Decision-Making (Capacity) (Amendment) Bill 2015. The proposed Bill will amend the Assisted Decision-Making (Capacity) Act 2015. The rationale provided for drafting an amending piece of legislation is to improve processes and safeguards for those who will make use of the new decision-making supports. The Committee has published a report making 64 recommendations about how the Bill can be improved. The report can be reviewed at this link -

## **Adult Wardship**

As directed by the President of the High Court - from April 22nd, the Office of the Wards of Court has stopped accepting wardship applications under Section 15 of the Lunacy Regulation (Ireland) Act 1871.

The Office of the Wards of Court will continue to accept applications under Section 12 of the Lunacy Regulation (Ireland) Act 1871. Applications will continue to be processed by the Office of the Wards of Court where there is an urgency due to concerns around areas including *but not restricted to* safeguarding, medical consent to treatment, detention and consent to transfer a patient where there are capacity concerns with respect to adult wards.

Any application brought under Section 12 will be accepted, processed and listed before the Court.

The Office of the Wards of Court will also accept applications where there is a need for a Court Order. There are no restrictions on incoming applications that require a listing before the Court for orders to be made. All proceedings under an Inquiry Order will continue to be heard and listed before the Court until commencement in June.

### **Summary – Court Discharge Applications from Wardship**

- From October 2022 it is expected to take three years to discharge all adult wards from wardship
- It is expected that three High Court Judges will sit five days per week hearing discharge applications
- A panel of 12 Judges will sit in rotation every 6-8 weeks depending on the legal term
- It is expected most applications will be dealt with in one sitting as applications will only be listed when all documents are filed and in order
- The projections of the number of applications set out in the table below allows for up to three adjournments in approximately 350 applications
- These projections have been calculated conditionally on the basis that three additional High Court Judges will be appointed to deal with the applications

## **HSE National ADM Implementation Plan**

Work is ongoing to develop a national ADM Implementation Plan. A draft version of the plan has been distributed to all relevant stakeholders for feedback and a number of meetings to obtain feedback on the draft plan have been conducted throughout April 2022.

The implementation plan will be published in mid May 2022. This will be disseminated to the system through the governance structures in the HSE.

## **HSE Disabilities and Mental Health ADM Groups**

HSE Disabilities and HSE Mental Health have each established ADM groups to consider and respond to issues which specifically relate to mental health and disability services.

The Mental Health Impact Assessment working group met on 12 April 2022 to review the proposed Terms of Reference and explore models of engaging staff in an impact assessment that will facilitate the implementation plan. It was agreed that this would be a time limited process and a timeline will be agreed at the next meeting.

The HSE Disability reference group met on the 3<sup>rd</sup> May 2022.

Further updates will be supplied in future status updates.

## **CHO 1 ADM Impact Assessment and Action Plan**

CHO 1 have completed an ADM impact assessment and action plan. The report, which will include a summary of next steps and recommendations, will be finalised by the end of May and will inform the National ADM Implementation Plan.

### **Communications**

The HSE National Office of Human Rights and Equality Policy are working with HSE Communications to ensure that information is issued to the system on a regular basis in preparation for the Act being commenced.

### **Prescribed classes of professionals**

A Health and Social Care expert working group - Prescribed classes of professionals has been established through the ADM Inter-Departmental Steering Group. The ADM Inter-Departmental Steering Group is chaired by the Department of Children, Equality, Disability, Integration and Youth and this piece of work is being led by the HSE on behalf of the Inter-Departmental Steering Group.

The purpose of Health and Social Care Expert working group is to provide advice and guidance on a scoping exercise to determine the resources required to enable the prescribed classes of professionals to undertake capacity assessments under the Assisted Decision-Making (Capacity) Act 2015.

This specifically pertains to capacity assessments for co-decision-makers and enduring powers of attorney.

A targeted consultation process with key stakeholders will take place in May 2022 examining how this particular requirement of the Act may work in practice; how the assessments can be delivered and implications for practice; and training requirements for staff.

## **HSE National Consent Policy**

The revised HSE National Consent Policy was launched on Monday 28<sup>th</sup> March 2022 by Dr Colm Henry, Chief Clinical Officer, HSE.
